Call-In Policy


Policy:

When responding to a call-in as described below, an employee will be given a minimum of four hours work at double their regular job rate, to cover the shift or task they were called in for. All hours physically worked, will be used in the computation of weekly overtime. Applicable shift premiums (Double Time) will be included for call-in pay. All Call-In Shifts pertaining to this policy must be authorized by the requesting management official.

A "call-in" is defined as an unscheduled request made by an appropriate management official for an hourly employee to return to the employment location (Preston County E-911 Center) to fill unforeseen emergency even staffing or shift that was not scheduled, due to an acute sickness or immediate family emergency that could not be scheduled. These situations usually give the employee being called in, less than 4 hours or less notice to be at their place of work to fill the needed coverage. Requests to come in for these types of situations can be voluntary or mandated.

C. Employee hire

Commissioner Smith made a motion to approve the employee hire of Adam Clarkson as a Regular Part-Time Public Safety Dispatcher for Preston County E-911 at \$17/hr. effective immediately. Old Business- Consideration and/or action

A. Per-Diem Policy

Commissioner Smith made a motion to approve the Per-Diem Policy. Commissioner Stone seconded the motion. Discussion called for. Commissioner Stone says the policy is good but needs something added for clarity. Commissioner Smith suggested adding a statement to it for the department head or elected official to sign off as to whether the person is authorized to receive the per-diem. Commissioner Stone noted that if any changes need to be made, they can go back and amend the motion. A roll call vote was taken with Commissioners Smith, Stone and Thomas voting yes. Motion carried. Commissioner Smith amended his motion to add the per-diem policy take effect January 1, 2024.

B. County Vehicle Policy

The commissioners, EMS, OEM/E911, and sheriff's department discussed the county vehicle policy.

A county vehicle policy will bring the county into compliance with Federal IRS Regulations to protect the county and employees when it pertains to anything that has to do with county vehicles. The only exemption to this policy is law enforcement, because it's part of their job and everyone else would be subject to pay fringe benefits.

Other discussions included: whether transport officers, utility officers and OEM/E911 are exempt from the County Vehicle Policy, who has arresting powers, transparency of the policy itself, the description of marked/modified vehicles covered under the IRS document, how the fringe benefit works and how it's reported,

C. Taxable Employee Benefits Policy

There was discussion of polo shirts, uniforms, hats and boots and who they belong to as it pertains to the proposed fringe benefit policy.

A work session was suggested for Thursday, January 4, 2024 at 9:30 a.m. with elected officials and department heads to work on the policies. Any approval of county vehicle and taxable employee benefits, will be tabled until the January 16, 2024 meeting.

D. Engagement Letter for Everhart, Brown & Devall LC-Research County Real Estate

Commissioner Smith explained his deed search findings regarding the piece of property, formally known as the Bretz School, as on December 10, 1984 in deed book 516/607 the Preston County Board of Education deeded the property over to the Preston County Commission. On December 17, 1984, in deed book 516/610 the Preston County Commission deeded the property over to the Bretz Community Association. No action was taken at this time.
