In response to questions regarding the Bretz School property currently assessed to the Preston County Commission at a Commission meeting on December 19, 2023:

In September 2011, the ownership of the Bretz School property was questioned. By letter dated September 26, 2011, to Mel Snyder, Prosecuting Attorney, the Assessor, Terri Funk, requested his opinion regarding the ownership of this parcel. The above referenced parcel was purportedly conveyed from the County Commission of Preston County, West Virginia, a statutory corporation, to Bretz Community Association, Inc., a corporation, by deed dated December 17, 1984, of record in Deed Book 516, page 610. However, the existence of this entity could not be confirmed with a search of the records in the Preston County Clerk's office or with a search of the records of the WV Secretary of State's office.

By letter dated October 21, 2011, Mel Snyder, Prosecuting Attorney, provided a Legal Opinion regarding the ownership of the Bretz School property. This letter indicates that a copy was provided to the Preston County Commission. His primary conclusion was that the 1984 deed was not effective because Bretz Community Association, Inc., had not been legally created at that time.

According to a search of the WV Secretary of State's records, Bretz Community Association, Inc., became a legal entity November 20, 2012. Please note that this entity did not exist prior to November 20, 2012, and specifically did not exist at the time of the December 17, 1984, deed.

In a letter dated November 13, 2013, to Janice Polce, Mel Snyder, Prosecuting Attorney, further addressed the ownership of the Bretz School property. His primary conclusion was that the 1984 deed was not effective because Bretz Community Association, Inc., had not been legally created at that time. His opinion was that the Bretz School property was still owned by the County Commission. This letter also references a November 4, 2013, Commission meeting and indicates that a copy of the letter was provided to the Preston County Commission.

A "Legal Status and Options for Bretz School Property" was provided to the Preston County Commission by letter dated January 7, 2014, from Mel Snyder, Prosecuting Attorney. This letter described five options for the Commission with regard to the property. This letter states that its purpose is to document his comments at a Commission meeting the prior day. Again, he states that the County Commission owns the property.

By letter dated February 25, 2014, Terri Funk, Assessor, informed Mel Snyder, Prosecuting Attorney, that the owner for the property would be listed as Preston County Commission for the 2014 tax year as per his letter of November 13, 2013. A copy of this letter was provided to the Preston County Commission.

By Lease Agreement dated August 3, 2015, of record in Deed Book 780, page 554, the County Commission of Preston County, WV, a statutory corporation and political subdivision of the State of West Virginia, leased to the Bretz Community Association, a WV nonprofit corporation, the Bretz School property as described in "Exhibit A". Exhibit A is a copy of the deed to the County Commission of Preston County describing the 2 acres formerly known as Bretz School. No release of this lease was found of record.

Based upon the above information, the County Commission has been aware of the issues with this property since 2011. Since the Commission leased this property to the Bretz Community Association in 2015, they apparently believed that they owned the property at that time.

This analysis is for the use and benefit of the Preston County Assessor's Office for the purpose of assessing interests in real property. This memorandum is not intended to be, and should not be construed as, a legal opinion for any purpose, and should not be used or relied upon by any other person or entity as evidence of ownership or for any other purpose. The analysis provided herein is not intended to serve as a substitute for the findings and conclusions of a court of competent jurisdiction reached after due consideration of competing interests.

In accordance with WV code §3-3-5c(a), the Commission of Preston County agree that emergency absentee voting shall be extended to voters who submit a proper request for voting and emergency absentee ballot and who are confined to a health care facility that is located within a 30 mile radius of the county seat of Kingwood, WV including all licensed nursing homes and licensed health care facilities within that radius provided that the voter has resided in the nursing home for a period of less than 30 days per WV Code §3-3-1(2).

# A. CRASE Active Shooter Training

# B. Spy Glass

Commissioner Thomas moved to approve the Agreement with SpyGlass for a snap shot audit between SpyGlass and the Preston County Commission and authorize the President to sign the Agreement. Commissioner Stone seconded the motion. A roll call vote was taken with Commissioners Thomas, Stone and Smith voting yes. Motion carried. (See attached.)

#### SpyGlass Snapshot Audit Agreement

This agreement, effective as of the later of the dates of signature below ("Effective Date"), is between **Preston County** ("Company"), and The SpyGlass Group, LLC, an Ohio limited liability company ("Auditor").

1. Primary Audit Services. Company is engaging Auditor as an independent contractor to analyze its primary telecommunications service accounts (Voice, Data, Internet, Cloud Services, SaaS Licensing, and Mobility) to seek cost recovery, service elimination and cost reduction recommendations. Company will provide Auditor with the materials required to perform its analysis and Auditor will conduct a Kickoff meeting with Company to review the materials provided and introduce Auditor's personnel assigned to the project. Auditor will deliver the recommendations to Company at a Summary of Findings meeting, implement recommendations that Company elects for Auditor to implement, and deliver a complete telecommunications inventory to Company. Upon completion of implementation, Auditor will conduct an Industry Benchmark Analysis ("IBA") Meeting to compare Company's spending and audit results against industry peers as well as all SpyGlass clients, officially bringing closure to the engagement.

While Auditor is performing its analysis, Company will not make changes or perform internal cost reduction analysis with respect to provider accounts which Company has included within the scope of Auditor's review.

- 2. Fees. Company will pay Auditor the applicable fee set forth below ONLY for Auditor recommendations implemented within twelve (12) months of Auditor delivering the recommendation to Company:
  - 50% of any "Cost Recovery", as defined below
  - 12 times any "Service Elimination Savings", as defined below
  - 12 times any "Cost Reduction Savings", as defined below

"Cost Recovery" is any refund, credit or compensation received by Company relating to past services or charges.

"Service Elimination Savings" is any monthly cost reduction received by Company relating to cancellation of any service, including monthly usage cost reduction (calculated as the average of the last 2 months of usage costs associated with the cancelled service).

"Cost Reduction Savings" is any monthly cost reduction received by Company relating to the modification, consolidation or negotiation of any service, account or contract, including post discount usage rate improvement (calculated as the (a) decrease in post discount per unit pricing realized by Company for any service, times (b) the average of Company's last two (2) months usage levels measured in such units for the modified service).

- 3. Invoicing and Payment. Fees for Cost Recovery are due as a one-time payment within 10 days of verification that Company has been issued the refund, credit or compensation resulting in such fees. Fees for Service Elimination Savings and Cost Reduction Savings are due as a one-time payment within 10 days of verification that the cancellation or other activity resulting in the Service Elimination Savings or Cost Reduction Savings has been completed. Auditor may issue separate invoices as different fees are earned.
- 4. Miscellaneous. This agreement is governed by the laws of the State of West Virgina, without regard to principles of conflicts of law, and may be executed by facsimile and simultaneously in multiple counterparts. Company agrees that Auditor does not warranty the overall performance, Company satisfaction, or data accuracy of any telecom munications related carrier, provider, software manufacturer or vendor at any time whatsoever during or after the term of this agreement. Each person signing this agreement on behalf of a party represents that he or she has been duly authorized to sign this agreement and to bind the party on whose behalf this agreement is being signed by that signatory. In the event of any litigation, proceeding or legal action arising out of or relating to this agreement, the prevailing party in such action shall be entitled to recover its reasonable attorneys' fees, court costs, and other expenses incurred in connection with such dispute or legal action, in addition to any other relief granted. AUDITOR SHALL NOT BE LIABLE TO THE COMPANY FOR INCIDENTAL, CONSEQUENTIAL, SPECIAL OR PUNITIVE DAMAGES, INCLUDING, WITHOUT LIMITATION, LOST PROFITS OR BUSINESS INTERRUPTION, WHETHER SUCH LIABILITY IS ASSERTED ON THE BASIS OF CONTRACT, TORT OR OTHERWISE, EVEN IF EITHER PARTY HAS BEEN WARNED OF THE POSSIBILITY OF ANY SUCH LOSS OR DAMAGE IN ADVANCE. IN ADDITION, IN NO EVENT SHALL AUDITOR'S LIABILITY TO COMPANY EXCEED THE FEES ACTUALLY PAID BY COMPANY TO AUDITOR.
