Mr. Anderson gave a presentation on the company he works for called Secure Solar Future. His company builds, owns, operates and maintains solar panels by utilizing a PPA, a Solar Power Purchase Agreement Service. The contracts run 20,25,30, or 35 years, with 35 years being the life of the solar panels.

This company works a lot with schools and essentially becomes their utility company. Secure Solar Future contracts a specific rate for the life of the contract so the customer can determine energy expenses for the future. The amount never goes up and if it doesn't produce, you are credited.

Mr. Anderson noted they employee students from the CTE program, at the school, to help install the panels which gives the students an opportunity to get hands on experience to decide if it's something they would like to pursue.

In addition, they also have a roofing company.

The commission will seek legal advice before entering into a contract and speak with the school system to see if they are interested in being involved.

9:45 a.m. Jennifer Cloonan, Frontier – Letter of Support

Jennifer Cloonan, Director of Cyber Partnership of Frontier, requested a letter of support for fiber internet expansion in Preston County.

In 2020, Frontier went into a major financial leadership transformation with all new leadership, and board of directors and set a goal to fiberize America and the specific goal was to build 10 million fiber locations by the end of 2025. They are more than 1/2 way there.

This year they built 388K new fiber locations, thus far and their goal is 1.3M locations.

West Virginia was allocated \$1.2 billion from a Broadband Equity Access and Deployment Program from the \$42 billion that was allocated nationwide to make internet available to all communities.

A full application is expected to open in September and run to November. She said the letters make a difference on the ranking of the project. The more support letters elevate and amplify the need for the people that make the decisions.
