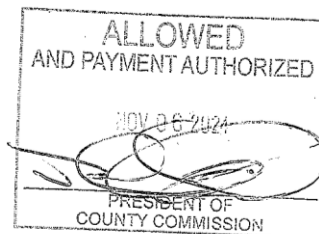

Commissioner Stone –

- She congratulated the Clerk’s Office and all the people that were elected to positions last night. She spoke to Sheriff Jim Fields directly and said they asked him to come in to help out the Sheriff’s Office in a time of distress and a lot of stuff going on and he accepted that. When she was leaving last night, she saw the Sheriff elect and congratulated him.

She thanked Sheriff Fields and said he is the epitome of integrity. She said he brought a lot of calm across the street and worked extremely hard and stayed on task at hand and was unwavering and that speaks of his experience and integrity. She thanked him again and said they picked the right person to fill the unexpired term, no doubt in her mind.

- Commissioner Stone attended the County Fire Association Meeting and said they are moving forward with ordering a mobile burn building for the potential property located below 911.
- She attended the 911 Advisory meeting and talked about the wrecker meeting that they are required to have every 3 years with all the wrecker companies in their rotation. The date for the meeting is December 19, 2024, at 6:00 p.m. at the 911 Center.
