2) Questions we are looking for feedback on from the county commission:

1. Considering our small population, rural landscape, and the size of the county, what recreation infrastructure do you view the county is responsible for providing to ensure a high quality of life and inclusive, equitable access to diverse recreation opportunities? Consider target groups such as our youth, parents, grandfamilies, and elders.

- 2. With your leadership experience, what needs do you see that the parks & rec dept. should address? As a resident, what do you want for yourself, family, and friends?
- 3. How can the county use the parks & rec dept. to maintain, promote, and celebrate our rural, Appalachian, small-town culture, its arts, and its history?
- 4. Are there tasks that the PCC currently manages that could be delegated to parks and recreation for efficiency if the department could expand a little? If we had a small crew for mowing, groundskeeping, snowblowing, fixing signage, etc., are there tasks they could assist with around the PCC building and other county-owned properties that you currently contract out?
- 5. What would it take for the parks & rec dept. to be worth 1% of the county's budget? (FY2024-25 approximate budget was \$11,500,000; 1% would be \$115,000)

- 6. What would it take for parks and recreation to be worth having 7 county employees with benefits? (3% of the county budget) For example:
 - Director
 - Manager of Park Operations & Maintenance (*potential for increased revenue from facility rentals)
 - 2 Parks Staff
 - Manager of Recreation Programs (*potential for increased revenue from program fees)
 - 2 Programs Staff

3) Community grants in the years past were a way the department was able to assist, interact, and build relationships with each community. If the Commission can increase our funding to bring on personnel to maintain our green scapes, trails, and park infrastructure, would the Commission support us offering their services to community parks for an annual partnership buy-in fee if they express interest in receiving assistance in maintaining their parks? This would help us again reach and assist these communities in an impactful way, as they too cannot get grant funding for labor. We could also assist them with grant writing, offering recreation programs if we have the additional program staff, playground inspections, and more.

4) Revenue generation and fundraising:

 Standard parks & rec revenue sources include services such as facility rentals and programs. Our county has yet to establish athletic complexes, community fitness centers, campgrounds,

pavilions with restrooms nearby, community arts centers, environmental education/nature centers, etc. To expand and offer services, the parks & rec dept. would need additional staff.

- Hotel/Motel An important but uncertain and insufficient source of funding.
- Levy Multiple staff needed to be able to run and administer one.
- Grants Do not fund human resources unless it is a specific project such as a fitness program and
 the fitness instructor needed to run it, an art program and the artist needed to run it, a music
 program or series and the musicians needed to teach or perform, etc. Often they will fund
 materials but not the oversight or labor to install or build. Volunteers are helpful, but often skilled
 labor is needed and overall volunteerism has been on the decline.
- Fundraisers The dept. has held raffles and events to raise money. The amount of money raised has never been enough to make it a worthwhile use of time.
- To make a bigger impact throughout the county and reach all of our communities, we need the county commission to pledge additional financial resources to the dept.
